Kayl: For every event, there is a significant amount of benefit. It is \$20 per person good investment. I see this as similar to funding Mock Trial.

Rep: no it is not one event. This will lead to the series for the whole year.

Josh: there is a difference from Mock Trial because unless you pay you cannot go.

Michelle: I agree that it is not like Mock Trial, I believe the org should be responsible for the funding.

Michelle: the pizza party is not similar to this because we referred to that as the one pizza recruitment meeting. This event however is for a speaker and does not seem to benefit the development of the organization. I do not see a good reason to fund food here.

Damani: I agree with kayl, if there is a speaker, it makes sense to have food but the necessity of the food here am not sure of. A meeting should not be for the food but for the actual event.

Samy: In the essence of the speaker event, it is fine. But as a finance board we have to use our own judgment to decide what is necessary or not.

Kayl: looking at the cost and the speaker, there could be no other intentions of the event.

Morgan: It is a long meeting with a lawyer and it would be disrespectful if there is a low turnout. Michelle: we should not look at speaker events based on the speaker. There is a fine line between beneficial information and a four-hour lecture. I am not sure what to say, it is very risky. There are also events that are successful without food.

David: there will always be different views on this topic. This is fine but you need to articulate the main principle that the policies uphold.

Morgan: we should not tell an org how best to advertise them. We should try our best not to micromanage.

Damani: it will be dangerous to think about the direct correlation between the ads and number of people that show up at the events.

Samy: the org needs to know that we are judging the event based on the student benefit. Buttons have always been an issue. Buttons are still giveaways even though they are long term.

Rep: the buttons were funded last year. It is not said anywhere on the forms that one should not request for buttons.

Kayl: the finance board changes every year. We see things we believe we should not fund and it is always after treasurer training. We have not funned buttons this year. It may change during the year but it depends.

Michelle: I am for buttons. So everyone has a different opinion about it. A flyer is easy to throw away however; I will not be for funding the button because your org will not be promoted. It will be limited to only the event.

Samy: The student body elects us and we look out for the umbc community ensuring that the funds are allocated for the best of use. We cannot fund everything.

Josh: we want to get most of all the moneys value
