



Communication

Our Executive Board placed the improvement of communication at the top of our list. In the previous year, we had problems arise with the knowledge of NRHH not just on campus, but also within our own membership. This year, we worked diligently to provide constant and effective feedback to the general membership at our bi-weekly general body meetings. Moreover, we completely redesigned our chapter website, much thanks to our Vice President of Recognition. All membership can look at the website to read recent updates, download chapter minutes, recommend new members, and submit OTMs. The main page of the website also includes a list of OTM winners and list of active members for the current academic year. Furthermore, we also created a chapter myUMBC group through our school website. It is yet another way to reach the campus population regarding NRHH news and for the promotion of OTMs.

In addition, as part of our commitment to the region, our Chapter President was in regular contact with the current AD NRHH. Our chapter membership was constantly aware of regional and national initiatives at general body meetings. The Chapter President gave regular presentations about new NRHH projects as well. We were also able to contribute ideas and brainstorm new avenues by participating in NRHH boardrooms at conferences. We felt that our best practices in our chapter could be shared with other chapters in order to improve overall involvement. Our Chapter President was active in the conversations about membership selection, induction ceremonies, and regional improvements. Most of the ideas shared have been traditions in our own Chapter, specifically the end of year OTM celebrations and honor cord requirements. In addition, our Chapter adapted some of the ideas from other campuses to our activities this year. We plan to include "apple polishers" for leadership at our end-of-year banquet and to begin celebrating National Residence Hall Month with small service projects. Our support for the regional level has culminated with the election of our Chapter President to AD NRHH for next year.

UMBC's myUMBC web portal was updated during Summer 2010 and our Chapter immediately took advantage of some of the new features it offered. First among these was the Groups interface, which gives our Chapter a profile on UMBC from which we can publish news articles, advertise events, and spotlight upcoming deadlines and service opportunities.







Lastly, we opened a Facebook page to encourage participation in service events on our campus. Most of our Chapter's members have joined the page to hear about service events on a regular basis. It has allowed us to invite other residents to participate in service events. In addition, we opened an application Facebook page to reach more residents on campus for membership. We posted the link to our website for easy access to the application.







Support

Office of Residential Life

Our NRHH Chapter has strong ties to the Office of Residential Life. We have developed this relationship for over fifteen years. We have continued that tradition over the years in order to serve our student leaders living on campus, as well as encourage student leadership, more effectively.

This past semester, we collaborated with Residential Life to bring the "Adopt a Family" service project back to campus. The NRHH Executive Board took a large leadership role in the project from the very beginning. We organized our strategy to allow each of the residential halls and apartment communities to "adopt" a family and provide presents for

the upcoming holiday season. As a chapter, we felt that we could revive this project because there were different scales of service occurring. Every resident can participate in small ways, while still making a large impact on the surrounding community. You could donate a gift, participate in wrapping the gifts, or spend the afternoon at Anna's House. Overall, we were able to provide ten families with wrapped gifts for the holiday season so that no one would be

without a happy holiday! The Office of Residential Life was able to support the Chapter in choosing Anna's House in Harford County, Maryland. We received direction and guidance from the Community Development Coordinator.

Furthermore, during the month of April, the Office supports us in celebrating National Residence Hall Month (NRHM) as part of the overall national initiative. We have planned two service events and a recognition program in support of NRHM. The Resident Assistants, Desk Staff, and Community Directors have all been educated about the importance of NRHM.

In addition to service projects, we also look to the Office of Residential Life to help us inform the campus community about our organization. We took time out of our schedules to talk with all of the professional staff, as well as invite them to our activities. Many of our professional staff has been inducted as honorary members over the years. Moreover, many staff members encourage their Resident Assistants, Desk Staff, and Maintenance Assistants to submit OTMs on a monthly basis. Last, but not least, we look to our professional staff to recommend potential candidates for membership in our chapter at the end of every semester.

Everybody's Favorite Resident: The Resident Student Association

The UMBC Chapter of NRHH and Resident Student Association have always worked together, in some capacity, to accomplish common goals for students in our residential communities. In previous years, however, the relationship between NRHH and RSA has been unclear, especially in the ties between both organizations. Previously, the connection between NRHH and RSA related strictly to budgeting purposes, as the budget for NRHH is included within RSA's

budget. However, NRHH has many more connections to RSA on a regular basis. Now, the Executive Boards of both NRHH and RSA collaborate in order to create a unified group of student leaders that advocate, recognize, and serve the community in which they live. Moreover, the NRHH President also serves on the RSA Executive Board as the Director of Service and Recognition. This position allows the organizations to grow together and have open lines of communication.

The connection between RSA and NRHH is more than just at the executive board level. RSA supports our Chapter in service and recognition on an individual level as well. First of all, RSA played a large role in the Adopt-a-family program, participated in our Relay for Life team, and funded a service event for National Residence Hall Month. On























the other hand, as part of recognition, we announce all of our OTMs at RSA general body meetings.

In May, we plan to collaborate with RSA for Donation Day. This is a residential campus initiative to "clean" and donate all unwanted items to Goodwill before moving out. Residents often have unwanted items or items that they cannot fit into their vehicles. This is an opportunity not to be wasteful. Lastly, we will celebrate and recognize our membership at our joint End-of-Year Banquet in early May. All of these achievements are proof of the solid relationship between NRHH and RSA.

Regional and National Levels

NRHH did not only want to continue to build relationships on campus, but also on the regional and national levels. Our chapter has participated in all regional conferences with at least the NRHH President in attendance. Some of the conference delegations included other Executive Board members and general body members. In addition, we attended the last national conference and participated in the National Business meeting. We plan on attending national conference again this summer, as well as submit programs in the leadership track.

Moreover, in order to keep lines of communication open between local chapters and the regional leadership, our chapter suggested the creation of a "Dropbox" account for CAACURH NRHH. This is an online database provided for no cost to the user. It allows all subscribers to participate in forums and share documents in a safe and organized fashion. Furthermore, the database keeps a copy of all documents submitted to create a time capsule of sorts. The current AD for NRHH and Recognition has been able to create and maintain a folder for CAACURH NRHH. She has provided all of the documentation for bidding and conference materials. This will serve as a useful resource for chapters of all sizes as well as allow for transparency between current NRHH Chapters. Our chapter intends to maintain a Dropbox for ourselves in order to make transitioning to a new Executive Board a smoother process.

Furthermore, we have participated in recognition efforts at the regional level. Our current President and Vice President of Service serve on the Regional OTM Committee. We have also provided a copy of our OTM submission guideline packet. We are in the process of producing a video about OTMs and OTM training to benefit all member schools. We are also highlighting OTMs during the celebration of National Residence Hall Month. Our simple recognition program involves "You're a Star" cards. These handmade cards will be randomly given to residents seen doing great acts of service or leadership.

One of the goals of the new Executive Board as we began over the summer was that we each had individual goals and objectives for our position. The NRHH President encouraged goal setting from the initial transition meeting in July. Every Executive Board member was expected to have personal and positional goals. These goals could be related to the Executive Board member's committee. In previous years, goals for the chapter were defined by the Executive Board as a whole. This often caused problems because the goals were lofty and hard to accomplish. Moreover, the goals were not personal and there was a lack of commitment to the improvement of the chapter. With the addition of personal and committee goals this year, the Executive Board could work on a small and large scale to improve the chapter.

Regional and National Involvement

Conference Participation

The conference attendance of NRHH members greatly increased from the previous year to this year. At CAACURH 2009, two NRHH representatives attended the conference; however, the NRHH President was not in attendance. This year at CAACURH 2010, six out of the eight members of the delegation were in NRHH, including the NRHH President and the Chapter Advisor. This is a significant improvement in participation and dedication from chapter members the previous year. In addition, at the CAACURH conference this year, three NRHH members, including the Chapter President, presented the first program in the NRHH boardroom entitled "How to Plan a Campus Service Event." The

members discussed different ways to participate in service to the larger community. At last year's CAACURH conference, no one from the delegation presented a program, and it says a lot that the program presented this year was the only structured program presented during the NRHH boardroom.

NRHH has also been represented at other conferences as well. Last year, all of the members of the No-Frills 2010 delegation were also members of NRHH. Once again, the NRHH representative was not our Chapter President. The delegation did not attend in person solely due to weather conditions. Moreover, in June 2010, four NRHH members and the RSA co-advisor were part of the NACURH 2010 delegation. Everyone present at the National Business meeting was an NRHH member.























Furthermore, all members of the No Frills 2011 delegation were members of NRHH. Additionally, our NRHH Chapter President bid for the AD NRHH position on the Regional Board of Directors for the following academic year. We are very proud to say that she was successfully elected to the position. Our chapter also won the Regional Building Block of the Year award, allowing us to bid at the National level. Overall, the representation and involvement of NRHH at conferences has more than doubled from what it was previously.

Not only has our chapter had increased attendance at conferences, but also we have increased participation in recognition at the regional level. Both our NRHH President and our Vice President of Recognition currently serve on the Regional OTM Committee. To further this participation, our Chapter has decided to contribute to the NRHH Buddy program being implemented by the current AD NRHH. Our Chapter hopes to strengthen our goals and membership by learning from other chapters' best practices. We have also provided documents and other forms of support to the Regional Associate Director for NRHH as we work to create them.

Conference Presentations

With the support of our Chapter President, Yvonne Allard (NRHH Treasurer) and Preethy Prasad (RSA Director of Events and future RSA President) were encouraged to create a presentation to share past and present service events sponsored by our chapter with members of other chapters at the Fall 2010 CAACURH conference. We thought, as a chapter, that it could be difficult to find solid service projects to sponsor on campus. Therefore, we decided to provide a variety of ways for other chapters to encourage service on their individual campus. The presentation included several different ideas for service, ways to promote service, and best practices from the UMBC campus. At the end of presentation, we showed a movie we made to promote a service event called Adopt a Family. Yvonne and Preethy joined forces to create a video to advertise the service event to the UMBC residential community. The video was created to encourage the students to donate new toys that were requested by children of struggling single parents living in an apartment community in Hartford County, Maryland. Incorporated into the video were clips of a variety of UMBC students, faculty, and staff answering three questions:

- 1. What does community service mean to you?
- 2. What does the season of giving mean to you?
- 3. How would you feel if you did not have some of the things or people you value in your life?

The video is available online at http://www.youtube.com/watch?v=Qyqzp37WLa0. After the movie finished, we invited all in attendance to participate in making paper cranes. This was a service























event we completed in the past. We donated all of the homemade paper cranes to a children's hospital.

This was the first presentation in two years at a regional conference thanks to the encouragement of our Chapter President and the Resident Student Association. It gave our chapter members the opportunity to interact with other NRHH member schools, while also allowing them to present to their peers. Our presenters were rewarded for their efforts by receiving CAACURH Top Programming pins.





Recognition

Our chapter has made very large improvements in the area of recognition. We've expanded our Of The Month program and begun using new awards to recognize members of our Chapter and Community Action Boards for the outstanding work they do.



Last year, NRHH suffered a low point in the area of recognition. NRHH members were submitting the minimum number of nominations needed to maintain active membership, and there was no expected standard for the quality of nominations.





As a result, few nominations were received and many of those that were sent in were very poor, including several written by professional staff members of the Residential Life Office. The Recognition Committee awarded few Campus Honorable Mentions and Campus Winners, and only two OTMs were recognized at the Regional level last year.





Our efforts to work with the Resident Student Association in the recognition of Community Action Boards (CABs) were

poor as well. NRHH purchased a teddy bear which was presented to a representative from a CAB once per month. The CAB receiving the bear was then expected to add something to the bear to represent their CAB and the CAB's achievement that month. Unfortunately, many CABs took far too much creative license with this. As a result, the bear had such items added to it as a belt of plastic bullets, a gang bandana, and what smelled like an entire bottle of perfume. Said perfume was so strong that nobody could bear to possess the bear for the necessary month, and so it was discarded early in the Spring 2010 semester (thus putting an end to NRHH's CAB recognition that year).

During the summer Executive Board retreat in July, we decided that we wanted new ways to recognize our membership. OTMs still provide the majority of our recognition efforts, however members of our general body often are not recognized through OTMs, as they are the ones writing the majority of our OTMs. To help remedy this, our President recommended that we introduce the CARP award. CARP awards, which stand for Caring And Responsible Person, are given at least once a semester to one person in each of our chapter's five committees. As each active member is required to serve on one committee, this helps to ensure that everyone has a chance of being recognized for going above what is expected of them. CARP awards are given as certificates by each member of the Executive Board, and are well appreciated by our general body members – some still have their certificates displayed on their room doors.



At the time of our Fall OTM Party in December, UMBC had received three Regional OTMs and one National OTM.

Since that time, both of these numbers have more than doubled. NRHH has also been recognizing Community Action Boards (CABs) with the F.R.O.G. (For Recognition of Growth) and SofE (Spotlight of Excellence) awards. Given once a month by the NRHH President at Resident Student Association meetings, these awards recognize CABs that we feel have made substantial improvements within their organization or otherwise done an exceptional job of engaging their community. Unlike OTMs, where a CAB must be nominated, and often by a member of the CAB to ensure it is detailed and accurate, these awards can be given to any CAB, which again helps ensure that

NRHH has also been working to support and recognize our community in other ways. In March 2011, James Dowtin Jr., a supervisor in UMBC's True Grit's Dining Hall, died of cancer. Recognition Committee member Tony DuLaney suggested that NRHH create a sympathy card to give to the dining hall staff and the deceased's family to show their support and appreciation for the work Mr. Dowtin had put forth for the residential community over its years of service. By the end of the week, NRHH had delivered a large card with dozens of signatures from NRHH members and other residents to the dining hall staff.

In support of National Residence Hall Month, NRHH produced a large number of "You're A Star!" cards. Two of these cards were given to every Resident

Assistant; each card had two Starburst candies taped to one side, and a large blank space on the other. Resident Assistants were asked to fill out the blank sides of these cards with some sort of appreciation for two residents of their choice, thanking those residents for outstanding service or support for their community.

It is in the Of the Month recognition program that we have made our greatest improvements, however. At the beginning of the semester, our Vice President of Recognition set a goal of getting more OTM nominations in every month of this year, at least two Regional Winners every semester of this year, and at least one National Winner all year. To ensure the success of these goals, he worked with the Recognition Committee to implement the following changes to our OTM program:

- New categories: We wanted to be able to recognize more people and programs, and make people more aware that they can really write an OTM about anything. Both of these goals were easily solved by adding five new categories to those offered at UMBC: Bulletin Board, Community Activities Board, Custodial/Maintenance, Desk Attendant, and Community Activities Board Program. In the Spring Semester, the Bulletin Board category was replaced with the new Passive Program category to allow our Chapter to forward these nominations to the Regional level.
- OTM guide: The Vice President of Recognition worked with the Recognition Committee to come up with a "Guide to OTM Writing" to hel what they should focus on when writing
 - with a "Guide to OTM Writing" to help those new to writing OTMs know what they should focus on when writing a nomination. Along with explaining the OTM program, the Guide advises writers to focus on adding lots of details, month-specific information, and engaging descriptions. This guide is available online at http://www.umbc.edu/rsa/nrhh/documents/OTM_Information.pdf and is attached to other advertisements for OTMs.
- Greater publicity: UMBC's web portal, myUMBC, underwent a significant change at the start of this year, and we have taken full advantage of its new features. Every month, OTMs are advertised with a "Spotlight", a rotating advertisement that appears at the top of myUMBC for the week before OTMs are due. Campus Winners are announced every week through a news article, and Regional and National Winners receive























additional news articles focusing solely on them. OTM certificates are now awarded during Resident Student Association meetings, and winners are also provided with door decorations to further advertise their achievement. As with last year, email announcements are also sent out to residents about the winners from each month.

- OTM Training: In past years, NRHH and Community Action Board members have gone through a short "training" to explain how the OTM program works and how to write a successful OTM. This year, this training was changed to be more interactive and engaging for those attending, using actual OTMs (that had been edited to remove names) to show trainees how OTMs were judged. This training was also shown to Resident Assistant staffs and the RA Council for the first time this year.
- Recognition of nominators: Starting in the Spring semester, the Recognition Committee has begun to announce during NRHH General Body Meetings the names of Chapter members that wrote winning OTM awards. The Committee also selects one nomination each month that they feel was the most outstanding across all categories. This "Of The Month Of The Month" is printed out and passed around during General Body meetings to demonstrate what a quality OTM looks like. It is our hope that this will help to inspire NRHH members to continue to write outstanding OTMs

With all of these new efforts, the effect on UMBC's OTMs is not only clearly visible but outstanding. In March, the total number of OTMs received during this academic year (July-June) exceeded our total from the previous year. During most months this academic year, we have received more OTMs than the same month in the previous academic year. The only exceptions were in November, where we received the same number of nominations as in November 2009, and in December and January, where we received fewer nominations. This is not unexpected, however, as we do not require NRHH members to submit OTMs in December or January, and most of our membership is not living on campus during that time due to UMBC's Winter Session. Quantity is not the only improvement we've noticed, but also quality. In the 2009-2010 academic year, UMBC received two Regional Winners and no National Winners. Already through March 2011, we have been awarded eight Regional Winners and two National Winners.



















Programming and Leadership



For the Adopt-a-Family wrapping party, we decorated a classroom in one of our residence halls with giant paper snowflakes, streamers, and paper lanterns. A large inflatable penguin also sat nearby ready to throw snowballs at gift wrappers.

Service

A large part of our Chapter programming falls into the area of service projects. We have worked diligently to provide a variety of service projects on and off campus to our general membership. In the previous year, most of our service projects were restricted to NRHH members and did not influence the larger community. This year, the NRHH Executive Board decided to resurrect a traditional project sponsored by the Office of Residential Life for many years. We led the Adopt a Family Service

project for the entire residential campus, including four apartment communities and six residential hall communities. At the completion of the program, we hosted a wrapping party for all of the gifts for the families. We also provided warm treats and all of the wrapping supplies to residents that wanted to participate in more than just donating. In addition, we spent a day at Anna's House (our partner organization for this project) with all of the families, especially the children. We made our own homemade pizzas and played many games. We also helped the children decorate cards for their families in light of the holiday season. Overall,

the program was a huge success and extremely fulfilling for our general body members.

Another tradition that we have created in our chapter is our peanut butter and jelly sandwich making parties. We choose one general body meeting every semester to incorporate service into our membership. This year, we have involved the Resident Student Association by hosting a second sandwich making party during their general body meeting. It allows us to bond UMBC NRHH Building Block Award

with each other while making sandwiches. We then donate all of the sandwiches to a homeless shelter to use for lunches. It is a very simple gesture, but an amazing service opportunity because it reminds us of the little things that make life worthwhile. In order to continue influencing the UMBC community we have even further adopted this event to include all interested resident students as well as RSA and our NRHH members by offering the service event just before a Community Action Board meeting in one of our first-year residence halls.

Some of our other service events that included not only our members but also the residential students were our Operation Write Home, where professionally designed cards were created to be sent overseas blank for deployed soldiers to fill out and send back home to their families as part of our efforts for National Residence Hall Month. This is a very refreshing service event because most of the cards that are sent overseas are already filled out and only show that

there are students concerned for the soldiers. These cards don't just show that we care but they also help create an open line of communication to the soldiers' families.

Leadership

We have decided, as the top one percent of residential leaders, that providing growth opportunities in leadership for our members is very important. In the past, this has been an area of great concern because we do induct the top one percent of leaders; it is difficult to encourage growth in leaders that are already amazing. Therefore, instead of focusing directly on leadership this past year, we decided to design a Fall Chapter Retreat that incorporated the meaning and history of NRHH. We divided the work for the retreat among the Executive Board. Each member was charged with creating an icebreaker or activity and a part of the information. We began the retreat with a reflection about the past year and the importance of togetherness. Then, we spent time reviewing expectations of an active chapter member and the expectations for future growth. General members were able to spend quality time with each other in an informal way as well as learn about the pillars of NRHH.

It was also a time for the Executive Board to step back and evaluate the future progress of our chapter. Therefore, we felt comfortable challenging our general























body to make improvements for this academic year. Some of the challenges included defining committee requirements and goals for the semester. Every committee member was assigned a job title, too. This allowed the members to take ownership of their position in the committee. It also allowed the Executive Board members to delegate extra activities to the membership. We were able to provide leadership opportunities on a small scale.

For our Spring Retreat we decided to rededicate our focus to leadership because our focus at the last retreat was mostly a review into the history of NRHH. The majority of the Retreat consisted of two specific leadership activities. Both activities required the members to evaluate their own leadership styles, and deduce how they could improve or change themselves to become better leaders. The first activity called for the members to choose from a sample of quotes placed on the wall and stand underneath one of them. There were some quotes that had several different people standing underneath them. Each member was then prompted to discuss what their quote meant to them and how they could personally relate to it. By participating in this activity, everyone was able to listen to different perspectives of the same

sayings and how each different member is more likely to perform as a leader themselves. The second activity was a more in-depth reflection of ones own personal leadership style. Those participating had to imagine themselves leading a group of people through some activity and decide what percentage of their energy they would spend on specific leadership qualities such as delegation, "carefrontation," inspiration, etc. After completing the individual sheets, an open discussion began where everyone was given the chance to share how the divided their energy and why they did so, eventually leading to a conclusion that everyone has their own leadership style and that there is no perfect leader, just that so many different styles work for different reasons based on the situation presented.























Growth of the Chapter

Overall, our NRHH chapter has shown tremendous progress in recognition, service, and leadership. We have been able take small steps and big leaps from a year of slow progress and struggles in leadership in all aspects of our membership. The greatest achievement of this past year has been to bring the membership closer, while continuing to focus on the pillars of NRHH. Our pillars are our foundation, but the membership brings the pillars into action. We have proven over the past year to be leaders in service and recognition. We have grown as leaders, specifically in character. Most importantly, we have been able to fill the missing piece of our Chapter; the meaning behind everything we do. It is said that NRHH is the top one percent of residential campus leaders. This is true. However, it is also true to say that NRHH is a family of residential leaders, growing and changing together. We support each other through struggles in our academic courses, as well as conflicts in every day college life. We provide a community where leaders can share best practices and the hardships of leading fellow peers. We may be limited in number, but the top residential leaders at UMBC are not short in passion.

Constitution of the University of Maryland, Baltimore County Chapter National Residence Hall Honorary

Enacted November 7, 2010

ARTICLE I: NAME

§ 1: This organization shall be entitled the University of Maryland, Baltimore County (UMBC) Chapter of the National Residence Hall Honorary (NRHH) of the National Association of College and University Residence Halls, Inc. (NACURH).



ARTICLE II: **PURPOSE**

§ 1: The purpose of this organization shall be to provide recognition for those students living in residential communities who have been of outstanding service and who have provided important leadership in the advancement of the residential community at the University of Maryland, Baltimore County; and to promote activities which encourage leadership qualities in residents.



ARTICLE III: **EXECUTIVE BOARD**

§ 1: Election of Officers:

- A. Officers of the UMBC Chapter, with the exception of the President, shall be selected by a majority vote of all active members present at the second-tolast meeting held in the spring semester and shall take office at the conclusion of the National NACURH Conference during the summer.
- B. Due to registration deadlines for the annual National NACURH Conference, the President shall be elected at least two weeks prior to the registration deadline for the National Conference, as determined by the RSA National Communications Coordinator.
- C. In exceptional circumstances, as determined by the current Executive Board, the election of one or more Officers may be moved to an earlier meeting provided that two week's notice is provided to all active members.
- D. All voting for Officers shall be conducted by secret ballot.

§ 2: Qualification of Officers:

- A. To be nominated for an Officer position within the UMBC Chapter, or to receive Chapter endorsement for a position on the Regional or National Board of Directors, a candidate must:
 - Hold Active status, as defined in Article IV, Section 5, Subsection
 - Be in Good Standing (not on Probation) ii.
 - Commit to living on campus at UMBC for the entirety of the following academic year
 - iv. Held membership in the Chapter for at least one full semester prior to nomination

§ 3: Officers and Duties

A. Chapter President

- The Chapter President shall conduct and preside over the meetings of the Chapter.
- The President shall call Chapter meetings at their discretion. ii.
- The President shall establish committees not defined herein and appoint the chairs of such committees.
- The President shall hold a position on the Executive Board of the Resident Student Association (RSA) and act as a liaison to RSA.




















- vi. The President shall approve all purchasing requests along with the Treasurer and Advisor.
- vii. The President shall maintain contact with the Regional Associate Director for NRHH and the Regional Communications Coordinator for NRHH Development.
- viii. The President shall attend all Executive Board and General Body meetings.
- ix. The President shall meet regularly with the Advisor.

B. Vice President of Recognition

- The Vice President of Recognition shall be responsible for monthly recognition efforts through the Of The Month (OTM) program, as well as other recognition efforts undertaken by the Chapter, and for tracking participation in recognition efforts by Chapter members.
- The Vice President of Recognition shall chair the Recognition Committee, which shall meet monthly to judge monthly OTM nominations.
- iii. The Vice President of Recognition shall submit OTMs chosen as Campus Winners to the Regional OTM Selection Committee.
- The Vice President of Recognition shall work with RSA and other organizations as appropriate to further recognition efforts at UMBC.
- v. The Vice President of Recognition shall attend all Executive Board and General Body meetings.

C. Vice President of Service

- The Vice President of Service shall be responsible for providing service opportunities and tracking service participation of Chapter members.
- ii. The Vice President of Service shall be responsible for coordinating at least three service projects per semester.
- iii. The Vice President of Service shall review and approve other service opportunity requests submitted by members
- The Vice President of Service shall chair the Service Committee, which shall assist the Vice President of Service in planning service events.
- v. The Vice President of Service shall coordinate with RSA to hold at least one joint service event each semester.
- vi. The Vice President of Service shall coordinate with other organizations as appropriate to further service efforts at UMBC.
- vii. The Vice President of Service shall attend all Executive Board and General Body meetings.

D. Treasurer

- The Treasurer shall maintain the chapter budget, collect induction fees as applicable, and pay chapter dues to NACURH.
- ii. The Treasurer shall preside over all meetings in the President's absence.
- iii. The Treasurer shall prepare requests for additional funding from RSA as necessary.
- iv. The Treasurer shall approve all purchasing requests, along with the President and Advisor.
- v. The Treasurer shall chair the Publicity Committee, which shall work to raise awareness of NRHH and its activities.
- vi. The Treasurer shall attend all Executive Board and General Body meetings.























E. Secretary

- i. The Secretary shall maintain records of all activities and meetings.
- ii. The Secretary shall maintain records of Chapter members, their status as Active, Alumni, Honorary, or Early Alumni members, and their standing with the Chapter.
- iii. The Secretary shall maintain the Chapter website and email listproc.
- iv. The Secretary shall chair the Inductions Committee, which shall organize the induction ceremonies to take place in the fall and spring semesters.
- v. The Secretary shall compile and submit all reports as outlined in Article VI.
- vi. The Secretary shall maintain up-to-date copies of the Chapter Constitution and Bylaws.
- The Secretary shall attend all Executive Board and General Body meetings.

F. Advisor

- The Advisor of the UMBC Chapter shall be a designated representative of the Director of the Office of Residential Life.
- ii. The Advisor shall attend all Executive Board and General Body meetings.
- iii. The Advisor shall approve all purchasing requests along with the President and Treasurer.
- iv. The Advisor shall meet regularly with the President.

§ 4: Removal from Office

- A. Active Executive Board members may be removed from their position for the following reasons:
 - i. Failing to maintain requirements of active membership as defined in Article V, Section 5, Subsection A, Clause I; or
 - ii. Failing to carry out the duties of their position as defined in the appropriate Subsection of Article III, Section 3; or
 - iii. Failing to serve as a model of good leadership at UMBC by being found responsible for violations of the UMBC Code of Student Conduct, UMBC Academic Integrity Policy, and/or Residential Life Policies; or
 - iv. Failing to carry out any additional duties or expectations listed in Chapter Bylaws, as applicable
- B. To remove an active Executive Board member from their position, the following procedure must be followed:
 - i. The Chapter Advisor must be consulted regarding the proposed removal
 - ii. Written notice must be provided to the Executive Board member in question.
 - iii. A vote must be held in a General Body meeting. If a majority of those members with voting rights present at the meeting vote in favor of removal, the Officer shall be immediately removed from their position.

§ 5: Succession

- A. In the event of resignation or removal of the Chapter President, the Treasurer shall assume the duties of the President until a replacement is elected.
- B. In the event of resignation or removal of any other Officer, the Chapter President shall appoint from the members of that Officer's Committee an interim chair to serve until a replacement Officer is elected.
- C. In the event of resignation or removal of any Officer:























- All active members and the Advisor shall be notified immediately.
- ii. An election shall be held at the following General Body meeting.
- iii. Should no replacement be elected, another election shall be held at the next General Body meeting.

ARTICLE IV: MEMBERSHIP

- § 1: The active membership of the UMBC Chapter of NRHH shall be limited to one (1) percent of the total on-campus population, or fifteen, whichever is greater.
- § 2: Membership in the UMBC Chapter shall be limited by an application process.
 - A. Nominations and applications for membership shall be received by the end of the ninth week of the fall semester, and by the end of the ninth week of the spring semester.
 - B. Nominations and applications must be made on the forms provided by the Chapter Executive Board.
 - C. Nominations may be made by the following persons:
 - i. NRHH members, regardless of membership status
 - ii. RSA members with voting rights
 - iii. Active members of Community Action Boards (to be verified by email to CAB President)
 - iv. Professional, graduate, and student staff employed by the UMBC Residential Life Office.
- § 3: Members of the UMBC Residential Community are eligible to apply or be nominated for active membership if they meet the following criteria:
 - A. Scholarship: The applicant/nominee shall hold a minimum cumulative grade point average of 2.5 and be in good academic and judicial standing at the time of application.
 - B. Residential status: The applicant/nominee shall currently live on campus at UMBC, and shall have previously lived on campus at UMBC for at least one semester prior to the semester of application.
 - C. Leadership and Service: The applicant/nominee shall have demonstrated outstanding leadership ability and dedication to service within the residential community.

§ 4: Selection

- A. The Selection Committee shall consist of the following members:
 - i. The Chapter President, to act as Chair, who may not vote except in the case of a tie
 - ii. The Chapter Secretary
 - iii. The Chapter Advisor, in an ex officio capacity
 - iv. The RSA President (regardless of NRHH membership)
 - v. At least three active members of the Chapter in good standing, chosen at the discretion of the Chapter Executive Board.
- B. The process of evaluation of nominations and applications shall be left to the discretion of the Selection Committee.
- C. Nominations may not be considered unless accompanied by an application submitted by the nominee.
- D. Members of the Selection Committee shall abstain from voting on applicants they nominated.
- E. Applicants must receive a majority of votes (50% + 1) from the Selection Committee in order to be selected for membership.
- F. The Selection Committee shall meet during the fall and spring semesters.
- G. Membership shall not be denied on the basis of race, ethnicity, religion, gender, gender identity, sexual orientation, creed, veteran status, national origin, ancestry, age, or level of ability.
- § 5: Types of Membership























- A. Active members shall be defined as those inducted members who are enrolled at UMBC as an undergraduate student, and are presently living on campus at UMBC.
- B. Alumni members shall be defined as those inducted members that have left on-campus housing, graduated, or transferred to another institution.
- C. Honorary members shall be defined as faculty or professional staff members or current students living off-campus who have made significant contributions to the residential community and have been chosen by the Selection Committee for their meritorious service to the residential community.
- D. Early Alumni members shall be defined as those previously active members who fail to maintain established membership requirements as outlined in Article V, Section 5, Subsection A, Clause i for two consecutive semesters.
- § 6: Requirements to maintain membership
 - A. Members of the UMBC Chapter are required to maintain a cumulative GPA of 2.5 or higher.
 - B. Additional requirements for membership shall be outlined in the Chapter Bylaws.



§ 1: The UMBC Chapter shall pay the annual chapter dues as established by the NACURH Services and Recognition Office in order to maintain the chapter's membership.

ARTICLE VI: CHAPTER REPORTS

- § 1: Member List
 - A. At the beginning of each academic year, a revised list of active members and chapter goals shall be submitted to the NACURH Services and Recognition Office.
- § 2: End of Year
 - A. At the end of the academic year, the following shall be submitted to the NACURH Services and Recognition Office, CAACURH Regional Associate Director for NRHH, and the President of RSA:
 - i. Reports of the outgoing officers
 - ii. A list of new officers with contact information, active members, and new inductees
 - iii. An updated copy of this Constitution
 - iv. Other pertinent information requested by the NACURH Services and Recognition Office
 - B. Each Officer shall be required to submit materials to aid with the transitional process to the newly elected Executive Board.

ARTICLE VII: AMENDMENTS, ENACTMENT, AND BYLAWS

- § 1: This constitution may be amended by a two-third majority vote of Chapter members with voting rights.
- § 2: This constitution shall be enacted and go into immediate effect with a two-third majority vote of Chapter members with voting rights.
- § 3: The Chapter may enact Bylaws at the recommendation of the Executive Board. Bylaws shall be enacted and go into immediate effect with a majority vote of Chapter members with voting rights.
























Bylaws of the

University of Maryland, Baltimore County Chapter National Residence Hall Honorary



- § 1 A member of the UMBC Chapter shall be considered in Good Standing if they meet all of the requirements listed herein for each semester of their membership, hold either Active or Alumni status within the Chapter, and are currently enrolled as an undergraduate student at the University of Maryland, Baltimore County.
- § 2 The requirements for Good Standing are as follows:
 - A) For Active members only, a member must attend all NRHH General Body Meetings. Active members are permitted up to two excused absences per semester. Alumni members are not required to attend meetings, but should remain aware of Chapter activities by reading minutes provided from each meeting. The Secretary is charged with keeping records of attendance for Active Members.
 - B) Members must submit two OTM (Of The Month) Award Nominations each semester. Active members only are permitted to skip up to two nominations per semester; Alumni members are not accorded this privilege. The Vice President of Recognition is charged with keeping records of OTM nominations for all members.
 - C) Members must participate in two service events each semester. These events may be hosted by the Chapter, or be outside events approved by the Vice President of Service. The decision for what qualifies as a service event is left to the discretion of the Vice President of Service. The Vice President of Service is charged with keeping records of service participation for all members.
 - D) Members must serve on at least one committee per semester as assigned by the Chapter President. All Committee Chairs are charged with keeping records of their committee member's participation.
 - E) Members must adhere to other requirements for membership designated by NACURH requirements, as laid out in the Constitution. The President and Advisor are charged with keeping records of compliance with these requirements.

§ 3 Probation

- A) Active or Alumni members of the Chapter currently enrolled as undergraduate students that fail to meet the requirements outlined in Section 2 above shall be placed on Probation for the first semester.
- B) The President may also place on probation, following discussion with the Advisor, any member that is found responsible for violations of the UMBC Code of Student Conduct, UMBC Academic Integrity Policy, and/or Residential Life Policies.
- C) The President, with agreement of the Advisor and a majority of the Executive Board, may also place on probation any member that has failed to adhere to the standards of conduct expected of the top 1% of on-campus leadership.
- D) Members on Probation will be provided notice of their probation by the President, Advisor, and the Officer placing the member on probation, as appropriate (as specified in the appropriate clause of Section 2).
- E) Members on Probation will be accorded one semester to return to Good Standing by meeting the requirements specified in Section 2; if placed on probation as a result of violations of policies as described in Section 3, Subsection B, a member must additionally be in good judicial and























- academic standing with the University in order to return to Good Standing with the Chapter.
- F) Members on Probation that still do not meet requirements for Good Standing after the following semester shall be placed on Early Alumni status by the Chapter President.

Passed with a vote of 20-0-0 on March 13th, 2011

BYLAW 02: Requirements for Honor Cords

- § 1 Members of the UMBC Chapter who are preparing to graduate as an undergraduate student shall be permitted to wear NRHH Honor Cords at their commencement ceremonies if they are in Good Standing with the Chapter and hold Active or Alumni membership in the Chapter.
- § 2 Members inducted in the semester of their graduation as an undergraduate student shall not be permitted to wear NRHH Honor Cords at their commencement ceremonies unless they meet the following requirements prior to graduation:
 - A) Participation in at least one service event, as approved by the Vice President of Service; and
 - B) Submission of at least three OTM (Of The Month) award nominations, as approved by the Vice President of Recognition.
- § 3 Members on Probation graduating as an undergraduate student may not wear NRHH Honor Cords at their commencement unless they meet all requirements to return to Good Standing at least two weeks prior to their graduation.
- § 4 Graduating members on Early Alumni status shall not be permitted to wear NRHH Honor Cords.

Passed with a vote of 20-0-0 on March 13th, 2011

BYLAW 03: Recognition Committee Procedures

- § 1 The categories for OTM nominations shall be selected at the discretion of the Recognition Committee from the list of those offered by the OTM Database.
- § 2 The Recognition Committee shall be responsible for reviewing OTM nominations and selecting from each category at most one Campus Winner and any number of Campus Honorable Mentions at their discretion.
- § 3 A Campus Winner shall be the most outstanding nomination in a category, provided the quality level of the nomination, in the judgment of the Recognition Committee, is sufficient for forwarding to the Regional Selection Committee.
- § 4 The Recognition Committee is not obligated to select a Campus Winner in any category, and may select a number of Honorable Mentions in the event no nomination is of sufficient quality. Likewise, the Recognition Committee is not obligated to select any Honorable Mentions for a category.
- § 5 Except where otherwise stated, all decisions of the Recognition Committee shall be made by majority vote.
- § 6 OTM Nominations of particularly poor quality may be deleted.
 - A) Any member of the Recognition Committee may make a motion to delete any OTM nomination they feel falls below the minimum expected level of quality, as determined by consensus of the Recognition Committee.
 - B) Following discussion of the motion, a vote will be held. If all members of the Recognition Committee agree with the motion, the Vice President of Recognition shall mark the nomination for deletion.
 - C) Nominations marked for deletion shall not count towards requirements for NRHH active membership; if a member's nomination is deleted and that member still has one or more "freebies" remaining, that deletion shall claim one of those "freebies."























- D) The Vice President of Recognition shall be responsible for emailing all OTM authors whose nominations are deleted to inform them of the deletion and the reasons for doing so.
- E) The Vice President of Recognition shall maintain copies of all deleted nominations for a period of at least two years.
- § 7 The Recognition Committee shall be responsible for recognizing all OTM winners and honorable mentions through certificates, public announcements, and at least one event per semester.
- § 8 Members of the Recognition Committee may not vote on nominations in a category in which they wrote a nomination or were nominated.
- § 9 The Recognition Committee shall meet once each month between the deadline for submission of OTM nominations at the campus level and the deadline for submission of OTM nominations to the Regional Selection Committee.

Passed with a vote of 19-0-1 on March 13th, 2011

BYLAW 04: Publicity Committee Procedures

- § 1 The purpose of the Publicity Committee is to design, copy, and distribute advertisements for NRHH applications and service events.
- § 2 As chair of the Publicity Committee, the NRHH Treasurer shall be responsible for:
 - A) Approving advertisements prior to approval by the Office of Residential Life for posting in the residential halls
 - B) Sending bi-weekly emails to the Publicity Committee immediately following every General Body Meeting.
 - C) Holding bi-weekly meetings of the Publicity Committee
- § 3 The Publicity Committee shall have three sub-chair positions:
 - A) Design and Approval Responsible for designing advertisements and sending designs to the Treasurer for approval of information and layout.
 - B) Approval, Photocopying, Separation Responsible for getting designs approved by the Office of Residential Life, photocopying approved designs, and counting and dividing photocopies into piles for each community.
 - C) Distribution Responsible for distributing pre-counted piled of advertisements to each residential community.

Passed with a vote of 19-0-1 on March 13th, 2011

BYLAW 05: Selection Committee Procedures

- § 1 The applications for NRHH inductions shall be read by the Selection Committee.
- § 2 New NRHH inductees shall be selected at the discretion of the Selection Committee from the list of those offered by the application pool.
- § 3 The Selection Committee shall be responsible for reviewing applications for membership and selecting applicants that fulfill the requirements of leadership, scholarship, recognition, and services at their discretion.
- § 4 All new inductees shall represent the top 1% of residential hall leaders in the semester in which they are chosen in the judgment of the Selection Committee.
- § 5 The Selection Committee is not obligated to select an applicant that does not complete the application in full or does not submit a sample OTM.
- § 6 Except where otherwise stated, all decisions of the Selection Committee shall be made by majority vote. If there is a tie, the President and chair of the Selection Committee may vote.
- § 7 Applications that do not meet requirements will not be reviewed.
 - A) The Chair of the Selection Committee will make a motion to delete any application that falls below the minimum expected level of requirement.























- B) Following discussion of the motion, a vote will be held. If all members of the Selection Committee agree with the motion, the Chair shall mark the application for deletion.
- C) All deleted applications will receive a letter from the Chair of the Selection Committee and the NRHH advisor, letting them know to apply again next semester.
- D) The NRHH President shall maintain copies of all deleted applications for a period of at least two years.
- § 8 The Selection Committee shall be responsible for reviewing the remaining applications.
 - A) The Chair shall read the application to the Committee.
 - B) The Committee, without the Chair's input, shall begin a discussion of the applicant for as long as necessary.
 - C) At the end of discussion, a vote will be called by the Chair of the Selection Committee.
 - All questions regarding the application will be taken by the Chair of the Selection Committee.
- § 9 All members of the Selection Committee are responsible for keeping the votes and inductee decisions confidential at all times.
- § 10 The Selection Committee shall be responsible for choosing up to three (3) honorary members every academic year. The same rules apply for the selection of honorary members as active members.
- § 11 The Selection Committee shall be responsible for announcing all new NRHH inductees within a week of the Selection Committee meeting with a letter from the NRHH President.

Passed with a vote of 19-0-1 on March 13th, 2011

BYLAW 06: Executive Board Election Procedures

- § 1 Candidates for a position on the Chapter Executive Board may be nominated by any active member, provided that the nominee qualifies for a position under Article III, Section 2 of the Chapter Constitution.
 - A) A nominee has the option of accepting or declining their nomination. Should the nominee decline, the nominee will not appear on the ballot.
 - B) Self-nominations are permitted provided the nominee qualifies for a position. Self-nominations imply acceptance of the nomination.
- § 2 Nominations may begin at any point up to and including the date of elections at the discretion of the current Chapter President. The opening of nominations must be announced at a NRHH General Body Meeting.
- § 3 When nominations have closed, as determined by the current Chapter President, the election process shall proceed as follows:
 - A) All candidates for the position currently up for voting will be asked to leave the room.
 - B) One candidate will be invited to re-enter the meeting room. This candidate may give a speech no longer than five minutes. This time may be extended by motion.
 - C) Following the candidate's speech, the current Chapter President shall moderate a question-and-answer period of no more than five minutes. This time may be extended by motion.
 - D) Following the question-and-answer period, the candidate will be asked to leave the room again.
 - E) The steps outlined in Subsections B through D continue until there are no candidates remaining for the current position.
 - F) When all candidates have presented themselves, the current Chapter President shall moderate a discussion of the candidates, to take no more than five minutes. This time may be extended by motion.























G) Following the discussion period, voting will begin using the method specified in Article III, Section 1, Subsection D of the Chapter Constitution.

BYLAW 07: **Induction Committee Procedures**

- § 1 The Induction Committee is responsible for organizing and executing the Induction ceremony for new members.
- § 2 Induction Committee members are expected to:
 - Assist in the selection and ordering of food
 - Set up and clean the location of the Induction ceremony
 - C) Procure appropriate decorations for the Induction ceremony
 - Draft short biographies for inductees
 - Read biographies at the Induction ceremony
- § 3 The Chapter Advisor shall be responsible for obtaining one white rose per inductee for presentation at the Induction ceremony.

BYLAW 08: Service Committee Procedures

- § 1 The NRHH VP of Service shall be responsible for:
 - A) Organizing community service events that General Body Members are able to attend
 - Overseeing the planning and implementation of NRHH service events
 - Delegate tasks within the Service Committee as a means to complete the planning of NRHH specific service events.
 - Approving service related advertisements prior to approval by the Office of Residential Life for posting in the residential halls
 - Holding weekly or bi-weekly meetings, at their discretion, for the Service Committee
 - Managing the Service Tracking Worksheet
- § 2 The Service Committee members shall be responsible for:
 - Attending service committee meetings
 - B) Offering ideas for service projects
 - The planning of NRHH service events C)
 - Advertisements for NRHH planned service events, in collaboration with the Publicity Committee
 - Performing additional publicity requirements at the discretion of the Vice President of Service
 - Set up/Clean up for NRHH planned service events
 - Pictorially documenting service events for the records

It is with great pleasure that I write this letter to support the CAACURH NRHH Building Block Award for UMBC. This year NRHH has had a truly remarkable year. They started the year with a great leader and executive board, set clear goals and strived to meet and exceeded each one of those goals. Thus, I believe they are most deserving of this award. In reviewing the criteria categories for the award I would like to highlight several of their accomplishments.

- Planning and execution of the Adopt-a-Family program; previously run by Residential Life, NRHH took over this program and it went very well, providing gifts and food to families in need at Anna's House.
- Increased membership and publicity; inducting nine new members and two
 honorary members this past semester, bringing our active membership total up to
 26 out of a possible 37 (historically their active membership has been much
 lower) They advertised much more and did great outreach to the broader campus
 community. This not only increased membership, but showcased the organization
 to the campus.
- Unveiled a newly designed website. Further, they have developed mechanisms for constant updates.
- They have increased conference involvement: the majority of the students
 attending the recent Regional Conference at College Park were NRHH members
 or were soon to be inducted into the Chapter; together these delegates worked to
 present the only NRHH-related program at the conference, and they were awarded
 with a Top 10 Program award for their efforts.
