CEC students will explore service and civic engagement through the lens and legacy of Sargent Shriver. Through course integration, weekly service, and reflective activities, CEC members build community and increase social change awareness.

- Enrollment in either SOCY396 or EDU216/PSYC (based on interest and/or schedule availability)
- Bi-weekly attendance at CEC Community meetings held Monday's from 12-1pm
- Involvement with a UMBC affiliated service site in the Greater Baltimore area. *Hours per week will be determined by site/type of service.
